REVIEW IMPLEMENTATION NOTICE: LINKED LICENCE CONDITIONS

TO:


- (1) the persons whose names are set out in Part 1 of the Annex (the “**Train Operators**”);
- (2) the persons whose names are set out in Part 2 of the Annex to this Review Notice;
- (3) Network Rail Infrastructure Limited (“**Network Rail**”); and
- (4) the Secretary of State, the Scottish Ministers and the Treasury,

together the “**Addressees**”.

- 1 This notice is a review implementation notice given under paragraph 7 of Schedule 4A to the Railways Act 1993.
- 2 On 20 December 2013, the Office of Rail Regulation (“**ORR**”) gave a review notice entitled “Review Notice: Linked Licence Conditions” (the “**linked licence review notice**”) specifying the relevant changes (within the meaning of Schedule 4A to the Act) which ORR proposed to make for or in connection with giving effect to its conclusions on a review of the licence conditions of the network licence granted to Network Rail (previously Railtrack PLC) on 31 March 1994, (the “**linked licence review**”).

Copies of the linked licence review notice were served on each of the Addressees.

- 3 On 11 February 2014 the ORR gave a notice of agreement entitled “Notice of Agreement: Linked Licence Conditions” (the “**linked licence notice of agreement**”) in respect of the linked licence review notice.
- 4 No relevant person gave a termination notice pursuant to paragraph 6 of Schedule 4A to the Railways Act 1993 during the period of 28 days beginning with the day on which the linked licence notice of agreement was served on it.
- 5 The ORR is therefore required by paragraph 7(1)(a) of Schedule 4A to the Railways Act 1993 to give a review implementation notice, and the ORR hereby gives notice that its conclusions on the linked licence review are to be implemented as proposed in the linked licence review notice and will come into operation on and from 1 April 2014.
- 6 In this notice, unless the context otherwise requires:
 - (a) words and phrases defined in the Railways Act 1993 (as amended) have the same meaning in this notice;
 - (b) words and phrases defined in the linked licence review notice have the same meaning in this notice; and
 - (c) the singular includes the plural and *vice versa*.
